**The Teen Shelter**

Family Services, Inc. recently received their Federal Grant that will enable operations from 2015-2018. The Teen Center and Shelter is currently in the process of being relocated. The new location, pictured above, is 1701 6th Avenue. The new shelter is less than one block from the Altoona Area High School and Altoona Area Jr. High School. The goal was to be in the new location by September 2015, but there were some roadblocks along the way:

- It took several months for code enforcement to approve plans, resulting in construction delays.
- It took 3 months to contract with a business to install the sprinkler system.
- Plumbing issues- prior to installing the sprinkler system, our plumber had to perform several tests. A major sewer issue was discovered and addressed.

Currently installation of a handicapped accessible bedroom and bathroom is in process. Once all construction is completed an application for licensing through the Bureau of Human Services Licensing will be submitted. While waiting to begin major renovations some minor projects were able to be completed with the help of community volunteers.

Look for an upcoming fundraising event organized by an Altoona Area High School student to benefit the Teen Shelter. The event is tentatively scheduled for the second week of February and will be an 80's-themed choral concert at the high school.

Appointments will be held beginning February 3, 2016 and run through April 13, 2016. For best selection of appointment times, please schedule early.

## **The Domestic Abuse Project**

The Domestic Abuse Project of Family Services, Inc. provides comprehensive domestic violence services to victims of domestic violence and their significant others in Blair County. The program was recently awarded a grant from the Pennsylvania Coalition Against Domestic Violence (PCADV) to open a Civil Legal Representation program. The Civil Legal Representation (CLR) program will provide victims of domestic violence with quality legal assistance, representation, advice, and financial assistance to cover court related expenses as they attempt to start a life free from violence. Domestic Abuse Project staff will assess each victim's needs and make referrals for eligible clients to the CLR program, which will provide legal representation for custody, spousal/child support, divorce, housing and public benefits. Referrals to the Civil Legal Representation program will come from the Domestic Abuse Project of Family Services Incorporated, including referrals from the emergency domestic violence shelter and the Protection from Abuse Office, as well as individual and group counseling clients. The Domestic Abuse project will utilize the Civil Legal Representation funding to hire one full time Staff Attorney, one part time Senior Managing Attorney, and one legal secretary. Due to the budget impasse, the opening of the CLR office has been postponed for several months, but now that funding for domestic violence services has been approved, the program is working to open the office as soon as possible. The tentative start date for the new service is March 1, 2016.

## **The Family Shelter**

The Family Shelter is currently in need of a larger shelter. The current shelter only accommodates 16 individuals. The shelter is always full. When a vacancy occurs it is filled

within hours. In the past fiscal year the Family Shelter provided shelter to 143 individuals and turned away 543 individuals due to the shelter being full. Lisa Hann, Executive Director, is collaborating with a group formed by Blair County Human Services made up of representatives from local community service agencies, local development corporations, elected officials, and interested community members. The goal of this committee is to build a shelter to accommodate 35-40 men, women, and children. This facility would be handicapped accessible and completed without mortgage so Family Services would only be responsible for operating costs. Realistically, operation costs at this new shelter would be higher than current operation costs.
