Parents as Teachers

The Family Resource Center continues to provide the evidence-based home visiting program, Parents as Teachers. Families with children prenatally to kindergarten entry are eligible for the program which focuses on parent-child interaction, development centered parenting, and family well-being. Families are visited twice per month and have an opportunity to attend a family group connection once monthly. In addition, children receive developmental screenings and families receive information and referrals which suit their needs. To date, 60 families with 98 children have received services in Parents as Teachers this year.

- Practical stress management and communication skills;
- Effective parenting skills and positive approaches to discipline.
